David McKenzie is a trial and appellate attorney with a focus on intellectual property. With appearances in over 60 trials, David is known for litigating matters to verdict before all levels of North Carolina courts, both federal and state (including the North Carolina Business Court). He also is part of the Olive & Olive team handling matters before the Trademark Trial and Appeal Board. David has a strong background in cyberlaw, entertainment and art law, unfair competition, constitutional law, and appellate matters.

David's litigation practice has included matters pertaining to copyright (including international copyright), trademark and patent infringement, antitrust, the interplay between free speech and intellectual property protection, misappropriation of trade secrets, constitutional questions (including freedom of speech, assembly, and religion), constitutional violations (including claims under 42 U.S.C §§ 1981 and 1983.), breach of contract, and other business torts. David has also handled transactional work including intellectual property and contracts.

In court, David has fended off injunctions under the Computer Fraud and Abuse Act, secured dismissals under the Electronic Communications and Privacy Act, persuaded a jury to find a California law firm not liable for trade secret misappropriation, secured dismissal of a patent suit under new database jurisprudence, and

persuaded a judge that state law claims were preempted by the Copyright Act. Although Olive & Olive does not accept matters outside the intellectual property field, David's past experience as a business litigator and in business formation helps him provide common-sense advice with an understanding of the interplay of intellectual property matters with other areas of the law.
